

# **RENTAL OF A CAMPING PITCH**

# **General Terms of Sale**

# **BOOKING OF YOUR STAY:**

Bookings can only be made by means of the reservation contract.

The reservation contract must be returned to us with a deposit of 64 €, plus the sum of 18 €, which corresponds to the administration fee. This deposit will only be cashed in after your reservation request has been confirmed by us. If we cannot reply favorably to your reservation request on the dates required, we will suggest other dates during which we are likely to be able to welcome you. If you cannot accept these dates, your deposit will be returned to you.

### **PAYMENT OF YOUR STAY:**

On receipt of your reservation contract and deposit, we will send you a confirmation of the booking of your stay. The outstanding amount of your stay will need to be paid before 12.00 o'clock noon on the day before your departure.

Payment by holiday cheques and by bank card are accepted.

Bank cheques are no longer accepted for the payment of the outstanding amount of your stay.

#### **ALLOCATION OF YOUR CAMPING PITCH:**

Your camping pitch will only be allocated on the day of your arrival. In case of no-show on the agreed arrival date in your booking, and without any news from your part, we will keep your booking until the next day 12.00 o'clock noon. Past this delay of compliance, we will dispose of the camping pitch without refunding your deposit of 82 €.

Minors must be accompanied by their parents or their legal guardians.

## **CANCELLATION OF YOUR STAY:**

In the event of cancellation of your stay, the following sums will be withheld:

## The administration fee

The deposit of 82 €, if the cancellation of your stay occurs more than 30 days before your arrival date.

We must be informed of the cancellation of your stay by registered mail with acknowledgment of receipt, date attested by postmark. **In case of early departure**, the dates on your reservation contract will be binding for the payment of the outstanding amount of your stay.

### **INFORMATION:**

Arrival on the camping pitches must take place after 12.00 o'clock noon and no later than 6.30 pm. Departure must take place before 11.00 am. The payment of the outstanding amount must be settled before 12.00 o'clock noon on the day before your departure. Any departure after 12.00 o'clock will be invoiced as an additional day.

Owners of dogs and cats must present an up-to-date vaccination certificate on the day of their arrival. The antirabies vaccination is **obligatory** for any animal which stays on our campsite.

Dogs of category 1 and 2 are not admitted.

# **OBLIGATORY CIVIL LIABILITY INSURANCE:**

For any stay at campsite Beau Rivage, clients are obliged to be insured by their own Liability Insurance. The campsite disclaims all liability in case of theft, fire, bad weather... and in case of an incident which falls under the civil responsibility of the client.

# **ADDITIONAL INFORMATION:**

The basic rate includes the single vehicle allowed per camping pitch.

Visitors are allowed after having presented themselves at reception. The payment of the visitors rate (5€) per person and per day does not give access to the swimming pool, which is strictly reserved for the residents of the campsite. In case of non-payment of the visitor's fee, this sum will have to be paid by the client who has accepted the visitor.

The reception is open from 8.00 am to 12.00 noon and from 1.30 pm to 6.30 pm.

The pool is open from 10.00 am to 12.30 pm and from 2.00 pm to 7.00 pm.

Swimming shorts are not allowed at the pool.

All tenants and campers are under obligation to conform to the internal rules of Camping Beau Rivage.
