



RENTAL OF MOBILE HOMES

General terms and conditions of sales

RESERVATION OF YOUR STAY:

The booking contract should be sent back to us with a deposit of 30% of the total estimated amount of your stay, plus the 25€ administration fee. The deposit will only be cashed in after we have confirmed the acceptance of your reservation request. If we cannot reply favorably to your reservation request on the dates requested, we will suggest other dates during which we are likely to be able to welcome you. If you cannot accept these dates, your deposit will be returned to you.

PAYMENT OF YOUR STAY:

Upon receipt of your reservation contract and your deposit, we will forward you a confirmation of the booking for your stay. The balance of your stay must be paid 30 days before your arrival.

If we have not received payment by the 30 -day term, we will consider your booking as cancelled and the general terms of cancellation, detailed under the heading "cancellation of your stay" will apply.

CANCELLATION OF YOUR STAY:

In case of cancellation of your stay, following sums will be withheld:

The administration fee.

An amount equal to 30% of the total amount of your stay, if your stay is cancelled more than 30 days before your arrival date.

The total amount of your stay if your stay is cancelled less than 30 days before your arrival.

We must be informed of the cancellation of your stay by registered mail with acknowledgment of receipt, date attested by postmark. In case of early departure, even the case of absolute necessity, no refund will be made.

GUARANTEE:

A deposit of **150€** must be paid upon arrival. This deposit will be returned to you on the date of departure, after the inventory of the fixtures of your mobile home has been done and after the deduction of possible costs for restoration and repairs of the material or for replacement of missing material.

The sum of **50€** will be withheld from the deposit if the mobile home hasn't been cleaned in a satisfactory way.

INFORMATION:

Arrivals must take place after 3.30 pm and departures before 10.00 am. During July and August the rental accommodations are solely rented out per week, from Saturday till Saturday. The mobile homes are rented out to those people whose names are mentioned on the rental contract. Any person that is not registered on the

contract will not be authorized to stay in the campsite, unless the direction gives him/her explicit agreement.
Animals are not allowed in the rental accommodations.

OBLIGATORY LIABILITY INSURANCE:

Whenever renting, a client is required by law to be insured by his own Liability Insurance. The campsite disclaims all liability in case of theft, fire, bad weather... and in case of any incident which falls under the civil responsibility of the client.

SUPPLEMENTARY INFORMATION:

Bed linen, bath linen and kitchen towels are not provided.

In order to be admitted, visitors must present themselves at reception. The payment of the visitors rate (5€) per person and per day does not give access to the swimming pool, which is strictly reserved for the residents of the campsite. In case of non-payment of the visitor's fee, this sum will have to be paid by the client who has accepted the visitor.

The reception is open from 8.00 am to 12.00 noon and from 1.30 pm to 6.30 pm.

The pool is open from 10.00 am to 12.30 pm and from 2.00 pm to 7.00 pm.

Swimming shorts are not allowed at the pool.

All tenants and campers are under the obligation to conform to the internal rules of Camping Beau Rivage.
